Lead Counsel is required to be present at the Mandatory Pretrial Conference on July 3, 2017 at 3:00 p.m. The Parties are instructed to discuss settlement options prior to the Pretrial Conference. Prior to trial, counsel shall make a good faith effort to resolve any objections in depositions to be presented at trial. All unresolved objections, together with argument and citations, shall be filed, with a copy to the Court, no later than five days prior to trial. Any objections not brought before the Court prior to trial shall be deemed waived. All Motions in Limine shall be filed on or before June 26, 2017. The parties are reminded to review the Court's <u>STANDING ORDER</u> as they prepare the proposed Consolidated Pre-Trial Order and in anticipation of their attendance at the Pre-Trial Conference.

The removal of a case from the Pre-Trial/Jury calendar for any reason shall <u>ONLY BE BY</u> <u>ORDER OF THE COURT AND MUST BE FILED WITH THE COURT BY JUNE 28, 2017</u>. A Motion for Continuance and/or Extension of Discovery must be by consent of all parties and a Consent Order submitted, at the same time as the Motion is filed with the Clerk of the Court.
