Failure to appear at the pre-trial conference shall subject the offending party to sanction, including dismissing of the complaint, counterclaim or cross-claim for want of prosecution or striking of defensive pleadings.

If the attorney or party wishes to appear by video/audio conference in lieu of personal appearance, he or she must contact Court Call at 888-882-6878 no later than 3:00 p.m. (EST) 3 court days prior to the scheduled hearing to make arrangements. Court Call charges each participant a fee for the appearance.

A scheduling order will be issued by the court at the conclusion of the pre-trial conference setting forth all deadlines for the remainder of the litigation, including the deadline for the filing of the consolidated pre-trial order.

Conflict letters must be filed in accordance with Uniform Rule 17.1.
