

However, after the Pretrial conference, a consolidated Pretrial order will be mandatory. Failure to submit such order may result in Plaintiff's complaint or Defendant's counterclaim/cross claim/third-party complaint being dismissed without prejudice, and Defendant's answer being stricken.

ATTORNEYS WHO WILL TRY THE CASE AND PARTIES REPRESENTING THEMSELVES ARE REQUIRED TO ATTEND THE PRETRIAL CONFERENCE ON THE ASSIGNED DATE AND TIME.

NO CONTINUANCES WILL BE GRANTED EXCEPT ON PRIOR ORDER OF THE COURT FOR LEGAL CAUSE SHOWN. THESE REQUESTS MUST BE IN WRITING AND RECEIVED IN THE STATE COURT CLERKS' OFFICE BY May 24, 2018. All conflicts shall be handled as required by Georgia Uniform Rule 17.1.
