
Parties must submit a **CONSOLIDATED** Pretrial Order by **August 17, 2018** in conformity with Uniform State Court Rule 7.2. **Failure to respond to this calendar, or to file the proposed Consolidated Pretrial Order**, may result in the parties and/or their counsel being held in **CONTEMPT** and/or in the **DISMISSAL** of the complaint, answer, counterclaim, cross claim or third party, as appropriate.

Lead Counsel is required to be present at the Mandatory Pretrial Conference on August 27, 2018, at 3:00 p.m. The Parties are instructed to discuss settlement options prior to the Pretrial Conference. Prior to trial, counsel shall make a good faith effort to resolve any objections in depositions to be presented at trial. **All unresolved objections, together with argument and citations, shall be filed, with a copy to the Court, no later than five days prior to trial.** Any objections not brought before the Court prior to trial shall be deemed waived. **All Motions in Limine shall be filed on or before August 17, 2018.** The parties are reminded to review the Court's Standing Order as they prepare the proposed Consolidated Pre-Trial Order and in anticipation of their attendance at the Pre-Trial Conference.

The removal of a case from the Pre-Trial/Jury calendar for any reason shall ONLY BE BY ORDER OF THE COURT AND MUST BE FILED WITH THE COURT BY AUGUST 17, 2018. A Motion for Continuance and/or Extension of Discovery must be by consent of all parties and a **Consent Order** submitted, at the same time as the Motion is filed with the Clerk of the Court.
