NO CONTINUANCES WILL BE GRANTED EXCEPT ON PRIOR ORDER OF THE COURT FOR LEGAL CAUSE SHOWN. THESE REQUESTS MUST BE IN WRITING AND RECEIVED IN THE STATE COURT CLERKS' OFFICE BY May 11, 2022. All conflicts shall be handled as required by Georgia Uniform Rule 17.1.
