This is a three-week jury trial calendar as listed below:


- **Week 1: March 14th-March 18th**
- **Week 2: March 21st-March 25th**
- **Week 3: March 28th-April 1st**

There will be no calendar call; the Court presumes your case is ready based on your announcement at the pre-trial conference. Counsel and/or Pro Se litigants are directed to appear as follows:

- **Positions #1-5 must appear in Courtroom 2A on Monday, March 14th at 9:00a.m. ready for trial. If your case is not reached on Monday, your case will be on 24- HOUR CALL for the remainder of the trial calendar.**
- **Cases that are *not* required to appear on Monday, March 14th will be on 24-HOUR CALL and must respond and appear in Court within 24 hours if called in for trial.**
- **Note: The Court will contact you using the contact information provided in your CPTO. If your contact information changes, please notify Ms. Videki before the trial period begins.**
- **If there are any pretrial matters that need to be discussed prior to the trial, contact Ms. Videki no later than one-week before the calendar to schedule a conference with the judge.**
- **If your case requires an interpreter, contact Ms. Videki no later than one-week before the calendar begins.**

The removal of any case from the trial calendar shall be only by email or order of the Court. Requests to be removed from the calendar must be sent to Wendy Videki, one week before the trial calendar begins. Continuances will not be granted except for legal cause. All conflicts shall be handled as required by Georgia Uniform Court Rule 17.1. Filing a conflict does not remove your case from the trial calendar.
