- If there are any pretrial matters that need to be discussed prior to the trial, contact Ms. Videki no later than one-week before the calendar to schedule a conference with the judge.
- If your case requires an interpreter and is not noted on the calendar, contact Ms. Videki no later than one-week before the calendar begins.

The removal of any case from the trial calendar shall be only by email or order of the Court. Requests to be removed from the calendar must be sent to Wendy Videki, one week before the trial calendar begins. Continuances will not be granted except for legal cause. All conflicts shall be handled as required by Georgia Uniform Court Rule 17.1. Filing a conflict does not remove your case from the trial calendar.
