CIVIL PRETRIAL CONFERENCE CALENDAR**



The parties are required to submit their consolidated pretrial order no later than five (5) days prior to the scheduled pretrial conference. If the CPTO is not submitted timely, the case will be continued to the next pretrial conference.

Please be prepared to discuss your filed Motions in *limine* and any filed objections. If Motions in *limine* have not been filed on behalf of your client, the Court will assume you did not intend to file any in this case.

Parties may request a continuance in writing to this Court's civil case manager — Wendy Videki (wvideki@dekalbcountyga.gov). Where a continuance is requested, the parties must provide a proposed amended scheduling order of all remaining deadlines for the Court's consideration.

The Zoom link will be provided via email before the date of the conference. If the preferred email address is different from the email address listed in Odyssey, please let Ms. Videki know which email address is preferred for the Court to provide the Zoom link.
