
If any party wishes to rely on evidence at this proceeding, please e-file any such evidence at least twenty-four (24) hours in advance.

If any party objects to proceeding with a virtual hearing rather than in person, a written objection shall be e-filed no later than June 29, 2022. A party that does not object in writing shall be deemed to have consented to a virtual hearing.
