
If any party wishes to rely on evidence at this proceeding, please e-file any such evidence at least twenty-four (24) hours in advance.

If a jury trial is not so demanded then a party shall be deemed to have waived right to trial by jury pursuant to Collins v. Jones, et al., 197 GA. App. 839 (1990).

If any party objects to proceeding with a virtual hearing rather than in person, a written objection shall be e-filed no later than July 25, 2022. A party that does not object in writing shall be deemed to have consented to a virtual hearing.
