Pending Motions which are ripe for decision are hereby placed upon the Court's Civil Motions Calendar scheduled for May 12, 2022 at 9:30a.m. **Counsel for the parties are required to be present via Zoom and are directed to contact the Court via email to the Civil Case Manager, Summer Schmidt (slschmidt@dekalbcountyga.gov), by May 5, 2022, regarding further instruction and technology for the hearing. If a party is not represented by counsel, the party must appear at the hearing. As a reminder, all corporations in Georgia are required to be represented by counsel in courts of record, pursuant to Eckles v. Atlanta Technology Group., 267 Ga. 801 (1997).**

If a motion for continuance is submitted less than 72 hours before the hearing, parties must email a courtesy copy of the motion and order to the Civil Case Manager, Summer Schmidt (slschmidt@dekalbcountyga.gov), or the motion may not be considered by the judge. If the case is settled or disposed of, please notify Ms. Schmidt, at 404-687-7135, and follow up with a pleading confirming dismissal or settlement at least 72 hours before the scheduled hearing.

Failure to respond to this notice may result in the dismissal of the pending motion, or any other action the Court may deem appropriate during the Hearing.

If the case is resolved in any manner, notify Ms. Schmidt via email: slschmidt@dekalbcountyga.gov and follow up with a pleading confirming dismissal or settlement at least 72 hours before the scheduled hearing.
