If a party is not represented by counsel, the party must appear at the hearing. As a reminder, all corporations in Georgia are required to be represented by counsel in courts of record, pursuant to Eckles v. Atlanta Technology Group, 267 Ga. 801 (1997).

**If a motion for continuance is submitted less than 72 hours before the hearing, parties must email a courtesy copy of the motion and order to the Civil Case Manager, Summer Schmidt ([slschmidt@dekalbcountyga.gov](mailto:slschmidt@dekalbcountyga.gov)), or the motion may not be considered by the presiding judge.** If the case is settled or disposed of, please notify Ms. Schmidt, at 404-687-7135, and follow up with a pleading confirming dismissal or settlement at least 72 hours before the scheduled hearing.

**Failure to respond to this notice may result in the dismissal of the pending motion, or any other action the Court may deem appropriate during the Hearing.**

If the case is resolved in any manner, notify Ms. Schmidt via email: [slschmidt@dekalbcountyga.gov](mailto:slschmidt@dekalbcountyga.gov) and follow up with a pleading confirming dismissal or settlement at least 72 hours before the scheduled hearing.
