**Consolidated Pretrial Order and Motions in Limine must be filed by: June 15, 2022.**  
**Mandatory Pretrial Conference to be held via Zoom: June 27, 2022, at 1:30 p.m.**  
**Trial Dates: July 18<sup>th</sup> through July 22<sup>nd</sup>**

DeKalb County continues to monitor the COVID-19 emergency and has the technology to conduct the calendar virtually. **Lead counsel must appear virtually for the pretrial conference. All parties shall contact the Court via email to the Civil Case Manager, Summer Schmidt ([slschmidt@dekalbcountyga.gov](mailto:slschmidt@dekalbcountyga.gov)), by June 15, 2022, for further instructions regarding proceeding with the Hearing using the Zoom application. Counsel must include ALL parties on any email correspondence with the Court.**

All cases should expect to be reached during the week of trial. Cases may be called out of order as scheduling demands. **Parties will be specially set for trial during the pretrial conference.** The parties are reminded to review the Court's **Standing Order** as they prepare the proposed Consolidated Pre-Trial Order and in anticipation of their attendance at the Pre-Trial Conference.

Parties must submit a **CONSOLIDATED** Pretrial Order in conformity with Uniform State Court Rule 7.2 by **May 26, 2022**, via email to Ms. Schmidt in **Word format**. **Failure to respond to this calendar by the deadline, or to submit the proposed Consolidated Pretrial Order to Ms. Schmidt, may result in the parties and/or their counsel being held in CONTEMPT and/or in the DISMISSAL of the complaint, answer, counterclaim, cross claim or third-party claim, as appropriate.**

All Motions in Limine shall be filed on or before **June 15, 2022**.

The **removal** of a case from the Pre-Trial/Jury calendar for any reason shall **ONLY BE BY ORDER OF THE COURT AND MUST BE FILED WITH THE COURT BY JUNE 15, 2022**. A Motion for Continuance and/or Extension of Discovery must be by consent of all parties and a **Consent Order submitted in Word format to Ms. Schmidt**, at the same time as the Motion is filed with the Clerk of the Court.


**Lead Counsel** is required to be (virtually) present at the Mandatory Pretrial Conference on **June 27, 2022** at 1:30 p.m. In preparation for the pretrial conference, parties are directed to:

- Email Ms. Schmidt a copy of the Consolidated Pretrial Order **in Word format**;
- Discuss settlement options **prior** to the Pretrial Conference and be ready to discuss settlement history with the Court;
- Discuss any motions *in limine* that have been filed and make a good faith effort to resolve them; and
- Discuss any objections in depositions to be presented at trial and make a good faith effort to resolve them. **All unresolved objections, together with argument and citations, shall be brought to the pre-trial conference, with a copy to the Court.** Any objections not brought before the Court prior to trial shall be deemed waived.
