THIS NOTICE DOES NOT SUPERCEDE ANY PRIOR NOTICE. Parties remain subject to call for trial pursuant to any prior calendar notice.

The removal of any case from the trial calendar shall be only by order of the Court, Continuances will not be granted except for legal excuse. In the event you have a legal excuse, please advise the calendar coordinator in writing. If a case is settled or otherwise resolved in any manner, the parties must notify the calendar coordinator immediately and follow up with a letter confirming dismissal or settlement.

The parties must submit a consolidated pretrial order in conformity with Uniform State Court Rule 7.2. Each litigant bears joint and several responsibilities for ensuring that the consolidated pretrial is filed. Failure to respond to this notice or to timely complete the proposed Consolidated Pretrial Order MAY WELL result in the dismissal of the complaint, answer, or counterclaim as appropriate; or to subject counsel or parties to contempt sanctions as the Court may deem appropriate; or alternatively, if the Court deems a lesser sanction is deserved in the removal of the case from the trial calendar.
