
The removal of any case from the motion calendar shall be by agreement of the parties, their attorneys, or by order of the Court.

Conflict letters must be filed in accordance with Uniform Rule 17.1.


The hearings will take place remotely using Zoom. The Court will provide a Zoom link prior to the hearings.


