- If there are any pretrial matters that need to be discussed prior to the trial, contact Tonay Burch, [tsburch@dekalbcountyga.gov](mailto:tsburch@dekalbcountyga.gov) no later than one-week before the calendar to schedule a conference with the judge.
- If your case requires an interpreter, contact Ms. Burch no later than one-week before the calendar begins.

The removal of any case from the trial calendar shall be only by email or order of the Court. Requests to be removed from the calendar must be sent to Ms. Burch, no later than one week before the trial calendar begins.

Continuances will not be granted except for legal cause.

All conflicts shall be handled as required by Georgia Uniform Court Rule 17.1. Filing a Notice of Conflict does not remove your case from the trial calendar.
