All parties shall contact the Court via email to the Civil Case Manager, Nakeya Burton (<u>nlburton1@dekalbcountyga.gov</u>), by <u>March 17, 2024</u>, for further instructions regarding proceeding with the Hearing using the Zoom application. <u>Counsel must include ALL parties</u> on any email correspondence with the Court.

All cases should expect to be reached during the week of trial. Cases may be called out of order as scheduling demands. **Parties will be specially set for trial during the pretrial conference.** The parties are reminded to review the Court's **Standing Order** as they prepare the proposed Consolidated Pre-Trial Order and in anticipation of their attendance at the Pre-Trial Conference.

Parties must submit a <u>CONSOLIDATED</u> Pretrial Order in conformity with Uniform State Court Rule 7.2 by <u>March 17, 2024</u>, via email to Ms. Burton <u>in Word format</u>. Failure to respond to this calendar by the deadline, or to submit the proposed Consolidated Pretrial Order to Ms. Burton, may result in the parties and/or their counsel being held in <u>CONTEMPT</u> and/or in the <u>DISMISSAL</u> of the complaint, answer, counterclaim, cross claim or third-party claim, as appropriate.

All Motions in Limine shall be filed on or before March 17, 2024.

The **removal** of a case from the Pre-Trial/Jury calendar for any reason shall <u>ONLY BE BY ORDER OF THE</u> <u>COURT AND MUST BE FILED WITH THE COURT BY March 17, 2024</u>. A Motion for Continuance and/or Extension of Discovery must be by consent of all parties and a <u>Consent Order submitted in Word format to Ms.</u> <u>Burton</u>, at the same time as the Motion is filed with the Clerk of the Court.

<u>Lead Counsel</u> is required to be (virtually) present at the Mandatory Pretrial Conference on March 25, 2024 at 1:00 p.m. In preparation for the pretrial conference, parties are directed to:

- Email Ms. Burton a copy of the Consolidated Pretrial Order in Word format;
- Discuss settlement options **prior** to the Pretrial Conference and be ready to discuss settlement history with the Court;
- Discuss any motions *in limine* that have been filed and make a good faith effort to resolve them; and
- Discuss any objections in depositions to be presented at trial and make a good faith effort to resolve them. All unresolved objections, together with argument and citations, shall be brought to the pre-trial conference, with a copy to the Court. Any objections not brought before the Court prior to trial shall be deemed waived.
