

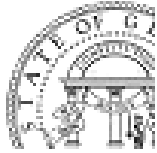
Dismissal of any case prior to the calendar call on **March 7, 2024** must be in writing and filed with the Clerk prior to the call of the calendar in order to be effective.
