
The Court will notify counsel and parties of the date they are expected to report for trial. The Court will endeavor to provide not less than 48 hours of notice. Cases may be called out of turn.

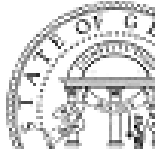
Parties, witnesses and persons who attend the trial will be required to comply with current health care standards including wearing masks and maintaining social distance.
