

No continuances will be granted except on prior written Order of the Court for legal cause shown. All conflicts shall be handled as required by Georgia Uniform Court Rule 17.2.



ORDER

Pursuant to O.C.G.A. §9-11-41 (as amended April 21, 2025), a plaintiff's written notice of dismissal *in toto* filed sixty or more days after the first original answer shall be deemed a motion for dismissal without prejudice. The Court shall grant the dismissal without hearing unless a Defendant files an objection within thirty days of the notice's filing. All such dismissals shall include any counterclaim(s) or crossclaim(s), and the Court will administratively close the file without further notice.
