

Dismissal of any case prior to the calendar call on **July 10, 2025** must be in writing and filed with the Clerk prior to the call of the calendar in order to be effective.


No continuances will be granted except on prior written order of the Court for legal cause shown. All conflicts shall be handled as required by Georgia Uniform Court Rule 17.2.
