(Via Zoom) in Courtroom B on the Second Floor of the Judicial Tower, located at 556 N. McDonough Street, Decatur, Georgia 30030.

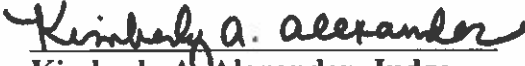
