ORDER

(Civil Pre-Trial Conference Calendar)

Counsel and *pro se* parties¹ in all listed cases are directed to appear in Court for the Division VII Civil Pre-trial Conference Calendar on **September 10, 2025, at 1:30 P.M.** (Via Zoom) The purpose of this Conference is to discuss the status of the case as well as schedule the case for mediation and trial.

At the Pre-trial Conference, counsel and *pro se* parties must be prepared to discuss the nature of any remaining discovery issues, all pending or anticipated motions, chances of settlement, length of trial, number of jurors, jury pre-qualifications, and court reporting of the case. Counsel and parties are expected to exchange documents and resolve any discovery disputes prior to the conference if possible. *Motions in Limine, disputed deposition designations, etc. will be addressed at a separate conference closer to the trial date.*²

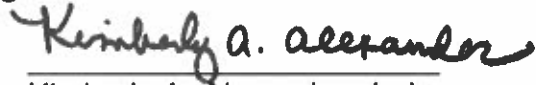
In lieu of a continuance request by the trial attorney due to a leave of absence or conflict, the Court encourages trial counsel to send another attorney with full binding authority to schedule the trial on behalf of the trial attorney and client. This will prevent delay in receiving a trial date.³

No continuances will be granted, except on prior written order of the Court for legal cause shown. A Motion for Continuance must be filed at least ten days before the Pre-Trial Conference, and a proposed Order must be submitted. Any party filing a late motion to continue must appear at the conference and present their motion.

Failure to respond to this notice may result in the dismissal of the complaint, answer, or counterclaim, and may subject counsel or parties to sanctions.

If a case is settled or otherwise resolved, the parties must notify **Michelle Cheek, Civil Case Manager, Division VII, at (404) 687-3985** or **macheek@dekalbcountyga.gov**, and follow-up with a pleading confirming the dismissal or settlement and a civil case disposition form.

² A Consolidated Pre-Trial Order will be due sixty (60) days before trial, but the Order need not be prepared for the Pre-Trial Conference.

³ *Pro se* parties must appear and may not send a non-attorney on their behalf.

ORDER

Pursuant to O.C.G.A. §9-11-41 (as amended on April 21, 2025), a plaintiff's written notice of dismissal *in toto* filed sixty or more days after the first original answer shall be deemed a motion for dismissal without prejudice. The motion will stand granted without entry of an order unless a Defendant files an objection within thirty days of the notice's filing. All such dismissals shall include any counterclaim(s) or crossclaim(s), and the Court will administratively close the file without further notice.
